Time limit for keeping the data	The time for which the complaint files may be kept in the personal file shall be 5 years after the closure of the procedure in order to be able to set up a comparison of previous decisions and to allow a harmonised application of the Staff Regulations. Any electronic communications in relation to this procedure must be deleted immediately after the complaints and the related decisions have been filed in the personal file.
