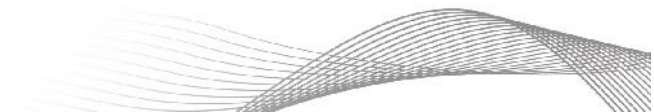


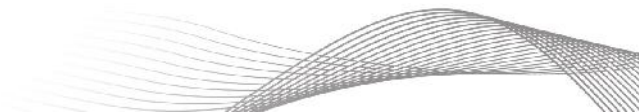

In particular the website implements:</p> <ul style="list-style-type: none"> • an EDPS contact form; • a form to send complaints to the EDPS on the way EU institutions process personal data; • a form for the EU institutions to notify personal data breaches based on the Regulation. <p>These processing activities are accounted for by other records you will find in the EDPS register and not by this record.</p> <p>The IT services of the European Commission (EC) data centre, where the EDPS website is hosted, may process website connection logs for information security purposes, including notably the IP address of the web client and the requested web resource. You can find more info in the relevant record in the EC register</p>
