The Safety Inspector, of the Safety at Work Inspection Service, coordinates the Specialised Services (a team of experts in the following fields: safety at work; fire prevention and environment protection; security, hygiene and health and, where appropritate, radioprotection of workers and plants) in order to verify the correct application of health and safety standard throught the JRC, according to the Italian Law. The Specialised Services carry out "Safety Audits" in all JRC Ispra buildings and,occasionally, in other JRC sites, and "Consultation Procedures", which address any works done on site that might entail any potentially hazardous situation. The Safety Inspector writes minutes of such meetings/audits wherein those present are listed. These are sent to line management and relevant safety figures.

The Safety Inspector also carries out machinary inspections, producing minutes that have a list of those who receive such minutes (hierarchy and maintainance service).

The Safety Inspector also carries out investigations following either injuries or near accidents. Where applicable, he writes a report that is sent to the hierarchy and safety line management of the Injured person. For statistical purposes, an excel file recording each accident is kept.

The Safety Inspector also manages a database of chemical substances that is used by all JRC staff that use chemical substances.

Finally, the Safety Inspector holds a meeting for all newcomers, according to "The Safe Start Procedure". A record of all newcomers is kept in an excel file to verify that the procedure is being applied.
