The objective of recording the unavailability of the experts is to avoid selecting experts who have repetitively failed to respect their commitment and prevent further prejudice to projects implementation.

As indicated in the statement of availibility, the penalty can be the exclusion from other tender procedures and contracts funded by the EC. The penalty will be limited in time according to the principle of proportionality.

It will be decided by the contracting authority of the Framework contract (and not of each individual specific contract/individual assignment) on the basis of the number of assignments where the expert did not respect his commitment .

The model of statement of exclusivity and availability together with the privacy statement indicate clearly the information required under art. 12 of Regulation 45/2001. The models of the statement of exclusivity and availability as well as the privacy statement are annexed.

The participation or not of the expert to the assignment is a factual element which cannot give rise to comments and there is no procedure set up for giving possibility to data subjects to comment.

Short term services for external aid are contracted via a multiple Framework contract (FWC) with on going competition. For each specific assignment, the Framework contractors (FWC'rs) in competition send an offer which includes CV of experts together with a statement of exclusivity and availability for each expert. In this statement, the expert commits himself to be available at the start date of his services for the period of execution foreseen.

The processing envisaged will record the availability or unavailability of the experts foreseen for the assignment.

The names & date of birth of the experts of the winning offer are encoded in CRIS (Common Relex Information System) when the offers are evaluated. The list of experts for a given assignment appears at the level of the specific contract in CRIS.

It indicates whether the experts have participated or not to the execution of the assignment.

The project manager can update this list during and after the implementation of the assignment. This information can be consulted by the CRIS users for each individual specific contract but only F4 can search it for a given expert.

The FWC is mostly used for short but key services, e.g. identification, pre-feasibility, mid term evaluation. The experts are usually external experts and very volatile.

It is envisaged to apply administrative penalty to experts who have not respected their committment such as exclusion of participation to the FWc assignments for a given period of time.

The statement of exclusivity and availability signed by the expert will refer to a privacy statement which will be published on the EuropeAid website, in the FWC pages.

8) Automated Processing operation(s):

No automated processing is foreseen.

A search tool will be put at the disposal of the unit in charge of managing the FWC, namely AidCo F4, to retrieve the experts who have not respected their statement of availability (search by names). Data related to the unavailability of experts will be subject to storage in CRIS but without any impact on other operations. Only a consultation of the content of the data base can be made.

Decisions resulting from the consultation will not be automatic nor recorded in the data base.

9) Manual Processing operation(s):

The availability of the experts is recorded at the level of the specific contract but CRIS. CRIS users cannot operate a direct research by experts' names. If the user who is consulting the database searches for the specific contract number in CRIS, he will be able to consult the availability of the experts who have been working for the assignment as any other information recorded for the specific contract (amount, payments modalities, subject etc.).

Only AidCo F4 will have access to the global information of a given expert for all the FWC assignments. This information will be used to assess penalties in conformity with the statements signed by the expert. The identification of the experts is recorded at the level of the selection of the offer of the FWC'r and may be updated when signing the contract, during or after its implementation. During or at the end of the assignment, the project manager can record whether the expert has or not participated to the assignment.

The FWC contracting authority may use this information in case of repeated unavailability of the experts in breach of the commitments they signed in their statements of availability and exclusivity.

The data for experts will be stored at the level of the FWC specific contract in CRIS and also in the CRIS data warehouse. The data warehouse is a sub-system of CRIS exploiting the CRIS data and is not accessible to users without special permission.

The legal basis is sound financial management of the budget of the EC as per Art. 27 of the Financial regulation. FWC operations are mainly financed out of external aid instruments and EDF and are subject to sound financial management since

- the Financial regulation of 10th EDF (European Development Fund) refers to it expressively,

- the instruments regulations, except ICI (Instrument for cooperation

with industrialised and other high-income countries and territories), indicate that its financial envelope "constitutes the prime reference amount for the budgetary authority according to point 37 of the Interinstitutional Agreement of 17 May 2006 between the European Parliament, the Council and the Commission on budgetary discipline and sound financial management" (recital 19 of the preamble of the ENPI regulation for example).

Processing the unavailability of experts can help improving the quality of external aid credits management. FWC experts presents high risks of unavailability. It is in the interest of the projects to have reliable experts for starting the assignments.

The FWC users encode in CRIS the participation of experts at the level of each specific contract. FWC users who have access to CRIS are RELEX DG's (+ DG with sub-delegated external aid credits) and EC Delegations in 3rd countries. The FWC users are exclusively the CRIS users already notified (cf. Notification DPO-752). All CRIS users have access to the data of each specific contract.

For the experts availability overview and search tool by name, the list of recipients is further limited to the unit in charge of this module, namely AIDCO F4 (cf. questions 7, 8 and 9 above).

There are no modifications or updates as regards the recipients globally indicated in the CRIS notification.

All CRIS users will have access to the record of availability of experts for a given assignment. Only AidCo F4 staff will have access to all records with a search tool for the unavailability of the experts.
