his processing is partly manual and partly automated, as follows: There is an electronic processing for each selection procedure, in the form of an EXCEL file that is kept in the Agency's network under the Safety drive. In addition, the relevant persons from the Network of the National Investigation Bodies are provided with the applications via the Agency Extranet (National Investigation Bodies area with restricted access). The electronic copy is stored under the relevant selection folder in the Safety drive and the restricted area of the Agency Extranet, dedicated to the applications following this call. Electronic copies are accessible only by the relevant staff members to the Safety unit (3), the members of the selection committees and the relevant persons from the Network of the National Investigation Bodies. The Appointing Authority and the supervisory entities

of ERA may have access to this data upon their request. (The applicants are requested to send their application in an electronic form).

#### 10/ STORAGE MEDIA OF DATA

As described above, the data are stored in electronic form on the Safety drive of the Agency and on the dedicated area of the Agency Extranet. The electronic files are accessible only by the relevant staff members of the Safety unit (3), the members of the selection committee and the relevant persons from the Network of the National Investigation Bodies who have been granted access to this restricted area.
