

Data Protection Notice EDPS-IPEN 2020 WEBINAR ON CONTACT TRACING APPS

The European Data Protection Supervisor (EDPS) processes your personal data to manage some aspects of the EDPS-IPEN 2020 webinar on Contact Tracing Apps of 21 October 2020.

We process your personal data based on Regulation (EU) 2018/1725 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC (hereinafter "the Regulation").

We provide the following information based on Article 15 of the Regulation.

Who is the controller?

The controller is the European Data Protection Supervisor (EDPS). For more information on the EDPS please consult our website: <u>https://edps.europa.eu</u>

The online meeting is supported by a webinar tool operated by TU Delft University acting as a processor, as mandated by the EDPS.

TU Delft also collects service usage data for aggregate statistics to monitor the utilization, performance, and availability of their webinar tool and servers, based on their legitimate interests.

What personal data do we process, who can access it and how long do we keep your personal data?

- The EDPS will record the audio and video of the events and publish them on its intranet, internet site and other EDPS social channels (Twitter, LinkedIn and YouTube).
 -) <u>Only if you are a speaker</u> you will need to switch on your camera and share your screen, as necessary.
 -) <u>If you are a participant</u>, we invite you <u>not to switch on your video and audio signals</u>. Should you do it, this will be under your personal responsibility.
- If you are a speaker, we will publish also the agenda of the meeting with your name, affiliation and intervention title. We might publish other personal data you provide us (hereinafter '-"other personal data") with at the event, such as presentations etc. We will publish this category of data <u>only upon your consent</u>.

We will remove event material including reports and audio-video recordings, at the latest after 10 years, so that it will no longer be available online or in directly accessible file systems. Some of the material may be transferred to the EDPS archives.

) The EDPS will process your chat messages sent to everybody to be able to reply to questions. The chat will not be recorded.

The online webinar tool, beyond video and audio footage and chat messages, collects some other pieces of your personal to be able to provide the service and monitor the utilization, performance, and availability of their tool and servers. Why do we process your personal data and under what legal basis?

The lawfulness of the processing of personal data for the management of the event is based on Article 5(1)(a) of the Regulation, the applicable legal basis is the Regulation itself, and in particular those provisions establishing the EDPS and its tasks.

The lawfulness of the publication of the "other personal data" you provide us with at the event such as presentations etc., is based on Article 5(1)(d) of the Regulation, i.e. on your consent.

What are your rights regarding your personal data?

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you.

You can send your request to the EDPS by post in a sealed envelope or use our contact form on the EDPS website (see section on contact details <u>below</u>).

How to withdraw your consent and the consequences of doing this

As to the withdrawal of the publication of "other personal data" please contact us and we will do it at the latest ten working days after your request.

Please note that withdrawing your consent does not affect the lawfulness of any processing based on your consent before it is withdrawn.

You have the right to lodge a complaint

If you have any remarks or complaints regarding the way we process your personal data, we invite you to contact the EDPS DPO (see section on contact details <u>below</u>).
