		The newsletter is sent from the AKIO platform to an EDPS functional mailbox that dispatches it internally to the professional email addresses to EDPS staff. Email addresses of EDPS staff are not provided to the processor, except for I&C staff who have access to AKIO platform in order to carry out quality control of the information collected so that only relevant articles will be included.
8.	Description of categories of persons whose data the EDPS processes and list of data categories	The EDPS processes the following categories of personal data of its staff in order to dispatch the newletter: name and professional email address.
		The following personal data of EDPS staff having access to the AKIO platform are processed: name and professional email address.
9.	Time limit for keeping the data	Personal data are processed by the EDPS as long as the staff member is a member of the EDPS. When a staff member leaves the EDPS, the account is disabled and scheduled for deletion. The account is kept, in the disabled state, for a maximum period of three months, after which it is deleted. The newsletter is sent from the AKIO platform to an EDPS functional mailbox that dispatches it internally to the professional email addresses to EDPS staff. Email addresses of EDPS staff are not provided to the processor, except for I&C staff who have access to AKIO platform in order to carry out quality control of the information collected so that only relevant articles will be included. Personal data will be processed for the duration of the service, while

		the data subject is a part of EDPS staff. The data retention period of personal data of EDPS staff who have access to the platform is set to 5 months after the end of the contract with the processor. Staff will receive the newsletter while being member of EDPS staff.
