### WEEKLY PRESS REVIEW

The EDPS uses AKIO Insights platform (<https://www.akio.com>) to deliver a weekly press review in the form of a newsletter directly in the professional mailboxes of the EDPS staff. The press review contains relevant articles about data protection, privacy and other topics of interest for the service.

We process your personal data based on [Regulation \(EU\) 2018/1725](#) ('the Regulation'). We provide you with the information that follows based on Articles [15](#) and [16](#) of the Regulation.

Akio Insights is the processor for the processing of personal data as described in this data protection notice.

Your personal data are processed in order to provide you with a weekly press review on relevant articles about data protection, privacy and other topics of interest for the service (such as, AI, big data, cloud computing, Internet of Things, cybersecurity, news from national Data Protection Authorities).

In order to provide you with the newsletter, the following data categories of all EDPS staff are processed based on Article 5(1)(a) of the Regulation in light of recital 22 (*'Processing of personal data for the performance of tasks carried out in the public interest by the Union institutions and bodies includes the processing of personal data necessary for the management and functioning of those institutions and bodies.'*): email addresses, name and surname. The following data categories of EDPS staff who have access to platform are processed: name, surname, email.

The newsletter is sent from the AKIO platform to an EDPS functional mailbox that dispatches it internally to the professional email addresses to EDPS staff. Email addresses of EDPS staff are not provided to the processor, except for I&C staff who have access to AKIO platform in order to carry out quality control of the information collected so that only relevant articles will be included.

Personal data will be processed for the duration of the service. The data retention period of personal data of EDPS staff who have access to the platform is set to 5 months after the end of the contract with the processor. Staff will receive the newsletter while being member of EDPS staff.

You have the right to request access to your personal data and to relevant information concerning how we use it. You have the right to request rectification your personal data. You have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you.
