# The EDPS - a young and dynamic institution

The European Data Protection Supervisor (EDPS), a young EU institution established in 2004, in Brussels, Belgium, is the independent data protection authority of the EU institutions and the advisor of the EU legislator on data protection matters. We strive to be an impartial centre of excellence in order to embed a strong data protection culture in the EU institutions and the legislation emanating from them. We also closely follow technological developments and try to anticipate their impact on the privacy of individuals. Our organisation employs about 120 staff members, most of whom are EU officials, but we also welcome Contract Agents and Seconded National Experts, working full-time or part-time.

### The EDPS - a great place to work

We value a strong culture of respect, flat hierarchical structures and an open door policy to foster innovative ideas and a strong collaboration between colleagues. To ensure our staff's well-being and motivation, we believe that it is essential to create a healthy organisational climate and to strike a good work-life balance. To achieve this, we offer various flexible working arrangements, as well as learning and development opportunities, such as job-shadowing and training programmes.

### WHO ARE WE LOOKING FOR?

- understands AI systems and related data protection issues;
- fits in an informal and friendly yet professional working environment;
- appreciates working collaboratively with other colleagues on a variety of different projects;
- brings their creativity and initiative to the table;
- engages constructively with stakeholders, based on our core values: integrity, impartiality, transparency and pragmatism.

#### **ABOUT THE POSITION**

Our job vacancies are in the **Supervision and Enforcement Unit**. The unit monitors the processing of personal data by the EU administration and ensures that Union institutions, offices, bodies and agencies (EUI) comply with data protection rules. Our core tasks range from conducting investigations and audits to handling complaints and prior consultations on processing operations. We decide on the best way to address identified issues, and we enforce the law, which includes using the EDPS' corrective powers, including administrative fines and litigation in the EU courts. As EUIs increasingly make use of AI systems, our unit will have to ensure the efficient application of the data protection rules to this new environment. We are thus looking for someone with a good understanding of AI systems and related data protection issues.

As a Legal Officer in the Supervision and Enforcement Unit, your main responsibilities will include:

- Monitoring compliance of the data protection rules by Union institutions, offices, bodies and agencies, in particular as regards the use of AI systems, including through investigations and enforcement actions, in line with the EDPS strategy 2020-2024;
- Handling of complaints from individuals or data protection associations relating to the processing of personal data by the EUIs:
- Handling of consultations and authorisations, incl. on transfers, from EUI's relating to their processing of personal data;
- Conducting of and participation in data protection investigations and audits, including in the context of Schengen evaluations;
- Developing and maintaining expertise related to data protection in various areas of EU law, including AI and digital regulation, as well as police and judicial cooperation in criminal matters, interoperability and large-scale IT systems;
- Engaging with internal and external stakeholders, in particular EUI Data Protection Officers, or national data protection authorities, either directly or through the European Data Protection Board (EDPB);
- Taking part in the work of the expert subgroups of the EDPB including through attendance at meetings and contributing to the drafting of documents;
- Contributing to the Unit's relations with other EUI; representing the EDPS in external meetings, and, where appropriate, in public events.

You may also be required to carry out additional tasks when necessary and in the interest of the service. These activities may require missions away from Brussels.

# **OUR ELIGIBILITY AND SELECTION CRITERIA**

# Eligibility criteria

For your application to be considered, you must meet the following criteria by the deadline for submitting applications:

- be a European Official in the category 'Administrator' in a grade between AD5 and AD9
   or
- be a laureate of an EPSO competition for "Administrators".

#### **Selection criteria**

For this job vacancy, we are looking for someone with the following essential and advantageous skills and experience:

#### **Essential**

- A university degree in the field of law and at least 3 years of relevant professional experience as a legal officer/lawyer, preferably in the field of data protection;
- Good knowledge of the data protection legislation and relevant case law of the Court of Justice of the EU;
- Good knowledge of the structure and functioning of the European Union and of its institutions, the treaties, and other fields of EU law in relation to the position;
- Very good problem-solving skills and creativity in proposing possible solutions in compliance with the applicable rules;
- Proven knowledge of AI systems and related data protection issues;
- Proven capacity for analysis and excellent writing skills;
- Demonstrated resilience in view of high workload periods and the ability to respond quickly and decisively in the case of urgencies;
- Very good organisational and prioritising skills in a very varied workload with demanding deadlines;
- · Ability to work in a proactive and autonomous way;
- Very good level of written and spoken English, which is the main working language of the EDPS and the EDPB Secretariat.

#### Advantageous

- Experience in a EUI, in particular with exposure to internal decision-making and legislative processes;
- Proven knowledge of specific EU data protection legislation applicable to EUIs in the area of Freedom, Security and Justice (e.g. Europol, Eurojust, EPPO, Frontex);
- Proven experience in conducting data protection audits, complaints handling, conducting administrative investigations, and/or data protection litigation in national or EU courts;

- Cover letter detailing why you are suitable for this role (PDF format of maximum size of 1MB);
- Official statement confirming current status as an official with date of establishment and grading and copy of the
  last two evaluation reports (for officials) OR EPSO attest (for EU competition laureates only/contract agents and
  temporary agents are not eligible);
- CV (preferably in Europass format);
- Optional: Other supporting documents, such as references, certificates, which must be merged into one single PDF document of a maximum size of 1MB.
