Dear [Redacted] (if I may),
Please find attached the draft agreement which has our amendments on board.
These were mostly of formal nature (we avoid in our MoUs any 'contractual language' like 'Party' etc). Moreover, we thought that the section "strategic matters" was already covered in substance by other sections and we deleted the section on "areas of cooperation" as we did not see any need to give a, in any event not exhaustive, list of areas. It is maybe beneficial to keep the MoU short and flexible.
Finally we added a clause in the new Para 6 which refers to the specific institutional roles of FRA and EDPS and that these should not be affected by the MoU.
So for us the document is in principle fine as it stands now.
