- The general Security Risk Analysis Report conducted years ago at the organization level targeted to assure the confidentiality, integrity and availability of the services and data managed by Frontex soon to be updated with the new information assets and services.
- The security controls and countermeasures assessment and their current status. Please note that the formatting will be updated later together with the content, in function of your feedback that we would like to get as soon as possible.

As previously discussed during our consultation, Frontex shall now perform a specific risk assessment for the new PeDRA system. The results of the PeDRA risk assessment should be completed towards the end of February, while the corresponding lacking countermeasures will be implemented in the system as soon as possible. We will also inform you about the planning of the implementation of these counter measures. We will appreciate your feedback asap.
